All Greenway clients will receive new versions of products as a no-charge update. The Greenway EHR certified solution is a package offering consisting of the EHR, Greenway Patient Portal, Greenway Insights and Greenway Electronic Case Reporting, and are available to new customers either through a one-time license fee, to include implementation service fees, and ongoing annual maintenance and support, or in a hosted model with an upfront implementation fee and ongoing monthly hosted service fees.
